** RERA was not applicable in Jammu & Kashmir, however, It has notified its own legislation named as 'The Jammu and Kashmir Real Estate (Regulation and Development) Act, 2018' on 16th December, 2018 which is similar to RERA.

*** West Bengal has enacted its own Act namely 'West Bengal Housing Industry Regulation Act, 2017' however, state has been advised by MoHUA to notify the rules under Real Estate (Regulation & Development) Act, 2016.

Summary:

- **30** States/UTs have notified rules under RERA; 4 North Eastern States (*Arunachal Pradesh, Meghalaya, Nagaland and Sikkim* are under process to notify the rules).
- **29** States/UTs have set up Real Estate Regulatory Authority (Regular - 20, Interim - 09) (*Lakshadweep is under process to establish*).
- **22** States/UTs have set up Real Estate Appellate Tribunal (Regular -13, Interim – 09) (*Andhra Pradesh, Assam Chhattisgarh, Goa, Himachal Pradesh, Kerala, Mizoram and Lakshadweep are under process to establish*).
- Regulatory Authorities of **24** States/UTs have operationalised their websites under the provisions of RERA. (*Assam, Kerala, Lakshadweep, Manipur, Puducherry & Tripura are under process to operationalize*).
- **43,927** Real Estate Projects and **34,729** Real Estate Agents have registered under RERA across the country.
